- Build public value for the arts in Arizona** by communicating the impact of your grant award to Arizona State Legislators and the Governor-appointed Commissioners of the Arizona Commission on the Arts.

*\*Maximum award is based on panel review ranking, available Arts Commission funding, organization’s budget at time of application and the submission of appropriate financial documentation. The Arts Commission receives its funding from the National Endowment for the Arts and the State of Arizona. This grant is made subject to the availability of those funds. If at any time during the fiscal year the Arizona State Legislature enters into session and reduces the Arts Commission’s state funding or if overall funding is reduced for any other reason, this grant may be reduced, canceled and/or may be paid out in installments.*
